CLIMATE							
Climate vary from hot (16°C/60.8°F - 40°C/104°F) to cold (7°C/46°F - 20°C/68°F) and from wet to dry depending on the time of year (an average of around 620mm falls between September and March). During May through August, nights and early mornings can be of low temperature and therefore warm clothing is essential. Guests should bring at least one warm jacket. Light but durable cotton clothing with a preference for dark green and khaki combinations or camo is the best.							
HEALTH AND INOCULATIONS							
Although Nkwali Eco Reserve is a very low risk malaria area it is recommended that precautions be taken against malaria. You should commence with a course of tablets at least one week before the safari starts and continue with it for a 4 (four) week period after the safari. There are no immunization requirements to enter South Africa unless you are from or have recently travelled through an area affected with smallpox cholera or yellow fever. Nkwali Eco Safari is situated only 35km/22 miles from the Nelspruit Medi-Clinic (Private Hospital), Lowveld Day Hospital and Nelmed Forum (Private Health Care). These hospitals offer World Class facilities and a full range of Medical services and procedures. In addition, Nkwali is within an 80km/50 mile radius of three Government Hospitals. Nkwali also have the privilege of having a Professional Registered Nurse in the form of the spouse of the Professional Hunter, who will accompany him during his stay at Nkwali. Travel and medical insurance is recommended. We undertake to exercise the most care and precaution to ensure our Client's safety.							

DAILY RATES INCLUDE

Full board and lodging (Brunch and dinner with non-alcoholic beverages only), transport from and to OR Tambo International (Minimum 6 nights stay at Nkwali) including linen, use of kitchen facilities, and camp staff. Hunting vehicles will be available 2 per day to collect and offload carcass and hunters. Guides/Profession Hunters, trophy preparation and skinning are included in the daily rates but excludes: insurance, trophy fees (taxidermy), mounting, dipping and shipping, on-estate excursions and day trips or tours.

HUNTING RULES

- Please be advised that the Professional Hunter ("PH") is the authority. He will manage the camp staff, trackers and skinners.
- In the unfortunate event of the client wounding an animal or dangerous game (Buffalo, Lion, Leopard, Hippo or Elephant), the PH will act as backup and may fire at any time in order to alleviate undue suffering of such wounded animal. He will make a on the spot decision if the client is fit to join him in the follow up. The PH is responsible for the safety of the client, trackers and crew and is the authority overseeing a safe and successful hunt.
- Please be advised for the "Big Five" hunt, you will not be allowed to hunt with a weapon firing an bullet smaller than 0.375 of an inch.
- Game will only be shot by calibre rifle that is legal in terms of the rules of the Mpumalanga Nature Conservation.
- All hunts must comply with the rules and regulations as set out by the all local authorities.
- All weapons will be kept unloaded. The instruction to load the weapon will be given by the PH.
- No liquor will be allowed on or during a hunt.
- Booking is confirmed by a 50% non-refundable deposit of the account with the balance thereof payable on arrival before the commencement of the Safari. Cheques and/or credit cards payments are not accepted.
- Confirmation of bookings will be send to the client via fax or e-mail, upon receipt of the proof of payment of the 50% deposit.
- Prices are subjected to change without prior notice to possible currency fluctuations. Prices on confirmed bookings are not subjected to change.
- Day of arrival and departure is counted as 1 hunting day.
- In the event of cancellation 180 days, or earlier, prior to the Safari commencement date, a 20% handling fee of the deposit will be charged, or, at the discretion of the owner be transferred to the following hunting season.
- The deposit for dangerous game is 50% of total safari (including trophy fee) to confirm the hunt and all payments may be made in cash, traveller's cheques, EFT (preferable).
- Any monies due to Nkwali Eco Safaris will accrue interest at a rate of 15,5%, as well as damage suffered by the owner and costs that occurred in respect of recovery of outstanding amounts.
- Non hunting observers may be permitted to hunt animals with prior arrangement with Nkwali Eco Safaris.
- All rifle scopes have to be tested and aligned on the shooting range before the hunt. It will give you the confidence and a feeling of readiness. From here it is what you came for, so relax and enjoy the hunt. Your host and PH will be to your assistance and help every minute of the day and night.
- The following documentation and actions are required BEFORE hunting and/or entering the farm:
 - Signing of Indemnity
 - 100% account payment
 - Shooting in of Rifles and Bows. This is compulsory to ensure the bow/rifle shoots true and that the hunter is capable of a safe and moral hunt.
- Hunting is allowed from half an hour before sunrise to half an hour before sunset.
- Hunting from or within 500 meters of vehicles is prohibited.
- If a satisfactory service was delivered by the Trackers/PH, tipping is encouraged but no liquor please.
- Hunting is only allowed under the supervision of the PH. No children under the age of 13 years.
- The breach of your gun must be open at all times, except after the animal hunted, is identified and ready to shoot.
- No firing of rifles outside the hunting time slot except on the Shooting Range.
- The hunter must never move from his hunting point unless agreed to by the PH. Hunter to only shoot in the direction shown by the PH.
- No fires in the field are allowed. Fire only allowed in Boma at Camp sites. No littering.
- Please ensure that cartridge shells, paper and litter are removed and only footprints remain.
- Shooting reptiles and species not on the hunting list, is not allowed. Any hunter shooting any of the above will be penalized with a 100% on top of the replacement value inclusive of transportation fees of such an animal.
- No dogs are allowed on the farm.
- All guests must complete, sign and deliver the indemnity form to Nkwali Eco Reserve Management or upon arrival at the Farm before any hunting activities commence. Guests are to note that entering the farm is done at entirely their own risk as indicated on this form and by entering the premises of Nkwali Eco Safaris, comply with the indemnity. Minors will sign the indemnity form, supported by their custodians.
- All guests are to sign the Species Hunting List/Orders.
- The premises are entered and activities are undertaken at own risk. The owners and/or employees accepts no responsibility for any injuries, mistakes, damage and/or death of any visitor/or property caused by the negligence or negligent act of any person during their stay at Nkwali Eco Safaris or on any hunting expedition, including accommodation, transport, vehicles and trackers, that are entirely or partially unsatisfying or not happening.
- Ownership of the game stays with the owner/s and may not be removed from the farm until all fees have been paid. It is suggested that hunters make provision to pay hunted game in cash or by EFT, as we do experience power cuts on the farm.

INDEMNITY
